## 1. Overview

Financial assistance is available to eligible applicants to help meet **HOUSEHOLD EXPENSES** for drought affected families, of up to a maximum of \$3,000 per family/household.

Assessment of this application and any decision to approve funding are matters for the CWA of Victoria in its absolute discretion.

**Please note that priority will be given to Victorian grant applicants that have not accessed Drought Relief funding through the CWA of Victoria since 1 October 2019.**

## 2. Funding

Our Drought Relief Fund has received monies for distribution monies from a range of funders, sources including, but not limited to, the Victorian Government (Household Financial Drought Relief), the Commonwealth Government, Coles, members of the CWA of Victoria, the general public and other organisations.

Eligible families include families of farmers, farm workers or farming dependent contractors in:

- A Shire/Council in Section 7 of this application form
- Dry land farming production in the Millewa region in north west Victoria (Victorian Government funding)
- Irrigation-based farming in the Goulburn Murray Irrigation District (Victorian Government funding)

## 3. Program Duration

Payments will be available until program funds are fully expended or until 30 June 2020; whichever comes first.

## 4. Expenses

Eligible household expenses must include purchases between 1 July 2019 and 30 June 2020. You must provide copies of evidence of your household expenses with your application.

**ELIGIBLE** household expenses include (but not limited to):

- Residential rates
- Groceries and food
- School expenses
- Household bills (electricity, gas, water,)
- Rent
- Telephone expenses
- Urgent dental and medical treatment.

**INELIGIBLE** expenses for payment include (but not limited to):

- General farm business expenses (e.g. equipment, irrigation, insurance, fodder)
- Capital works
- Farm rates notice – without your principal residence
- Expenses that do not incur an invoice or receipt
- Household expense purchases before 1 July 2019.
